Much to our relief, the global efforts against the COVID-19 pandemic are slowly reaping rewards. Nations are cautiously opening their borders and adjusting travel restrictions. This has allowed some assessments to be conducted onsite.

This era of change sees the departure of our inaugural Chief Executive Officer, Mrs. Maureen Primrose Mutasa, who led this organization from its establishment in 2008. After thorough consideration, the SADCAS Board of Directors has placed this crucial role into the expert hands of Ms Eve Christine Gadzikwa. She will provide visionary leadership and drive SADCAS to achieve its strategic objectives.

June 9th, marks World Accreditation Day (WAD) as a global initiative jointly established by the International Accreditation Forum (IAF) and International Laboratory Accreditation Cooperation (ILAC) to raise awareness of the importance of accreditation-related activities. Accreditation: Sustainability in Economic Growth & the Environment is the theme for 2022 WAD.

WAD Celebrations in the region ranged from circulation and publication of press releases in the various national media, circulation and posting of WAD video on social media, television interview to virtual and physical workshops/seminars.

SADCAS COMMUNIQUE - SADCAS CEO MAUREEN MUTASA RETIRES

SADC ACCREDITATION CHIEF BOWS OUT AFTER STORIED CAREER



AFTER 14 years at the helm of the Southern African Development Community Accreditation Service (SADCAS) and a career spanning over 40 years in standardization, quality assurance and accreditation, Mrs. Maureen Mutasa will retired as Chief Executive Officer of the SADCAS at the end of June 2022.

SADCAS assures the technical competence of providers offering calibration, testing, medical laboratory and inspection and certification services in 14 countries across Southern Africa

Through this role, the organization is also a key enabler of trade and the protection of health, safety and the environment within the SADC bloc.

Mrs. Mutasa was appointed SADCAS' founding Chief Executive Officer in June 2008 and with an initial grant from the Norwegian Government, she has been at the forefront of establishing the accreditation body as a globally recognized institution.

At its inception, SADCAS was the first multi-economy accreditation body in the world, a model that has since been replicated in the Gulf, French-speaking West Africa and the Caribbean.

"It all started with the vision of a few of us in the SADC standards, quality assurance, accreditation and metrology structure believing that we can create this multi-economy accreditation body to service a number of the countries within the region, most of which did not and still do not have the capacity to do so alone," Mrs. Mutasa says.

"Being the first is never easy. The first leg can often determine the destiny of an organization, and we experienced the ups and downs that all start-ups do, but I believe we have proved that the SADCAS model is a viable, cost effective and sustainable way of providing accreditation services to a number of countries."

During her pioneering tenure, SADCAS has received international recognition for six (6) of the eight (8) accreditation schemes it offers. It has issued 259 certificates to 209 accredited facilities in 13 of the 14 SADC Member States it services and two (2) non-SADC countries Ghana and Cote D'Ivoire. Dependency on Government funding reduced from 100% as at 31 March 2009 to 14% as at 31 March 2022 having prevailed through the height of the COVID-19 pandemic by swiftly adapting and migrating to remote assessments and online training. Over the years, Mrs. Mutasa has contributed immensely to the development of accreditation infrastructure not only in the SADC region but also in Africa as a whole.

Mrs. Mutasa retired as one of the Continent's foremost authorities on accreditation, standardization and quality assurance. Her diverse experience extends across the food industry, agricultural research and management.

She has been a member of the International Accreditation Forum (IAF) Executive Committee and the Joint International Laboratory Accreditation Cooperation (ILAC)/IAF Executive Committee.

Mrs. Mutasa has also served as Chair of the ISO Policy Committee of Developing Countries (ISO DEVCO), Vice Chair of the African Accreditation Cooperation (AFRAC) and Chair of the SADC Accreditation Cooperation (SADCA) and Chair of SADC Cooperation in Standardization. She is currently the Chair of the AFRAC Mutual Recognition Arrangement a position which she will carry to the end of her term in September 2023.

She is an experienced peer evaluator for the African Accreditation Cooperation (AFRAC) and Asia Pacific Accreditation Cooperation (APAC) and has undertaken various peer evaluations of accreditation bodies in Africa (Kenya, Egypt, Mauritius) and in the Asia Pacific Region (Japan, India, Thailand).

Prior to joining SADCAS, Mrs. Mutasa spent 20 years with the Standards Association of Zimbabwe (SAZ), where she managed the National Food Laboratories, set up the Standards Development and Training units and rose through the ranks to the position of Director General – a position she held for 8 years until her departure to join SADCAS.

Her management experience includes directorships on various company boards including the South African National Accreditation System; Zimbabwe Food Standards Advisory Board; Dairibord Holdings; and Standard Chartered Bank Zimbabwe among others.

On what comes next, Mrs. Mutasa intends to continue to contribute to the development of quality infrastructure

across Africa with a focus on the accreditation pillar.

A distinguished scholar who holds a first class degree from University of Wolverhampton (UK) and a Masters Degree in Food Science with Distinction from the University of Zimbabwe, a Beit Scholar, Eisenhower Fellow and Standard Chartered Bank Singapore International Foundation Scholar, Mrs. Mutasa is passionate about imparting the knowledge she has acquired throughout her career. She has lectured on Food and Animal Microbiology and Biochemistry at graduate and post-graduate level at the University of Zimbabwe, and she hopes to inspire the next generation of female leaders.

"It has been a long, but very fulfilling journey," Mrs. Mutasa says. "I am delighted to say I leave SADCAS with so many happy memories and I am grateful for the many people that have contributed to my journey. As the Yoruba Proverb goes, "If we stand tall it is because we stand on the shoulders of those who came before us."

SADCA HOLDS 2022 WORLD ACCREDITATION DAY WORKSHOP

The inaugural Southern African Development Community Cooperation in Accreditation (SADCA) Regional World Accreditation Day(WAD) was successfully celebrated virtually on the 9th June 2022 under the theme: Accreditation: Sustainability in Economic Growth and the Environment.

The SADCA Regional WAD workshop was attended by more than 190 participants from various backgrounds including the public and private sectors, SADCA members, conformity assessment bodies, and several associations within the Southern African Development Community (SADC) region.

In his capacity as SADCA Marketing and Communications Committee (MCC) Chair and the Master of Ceremonies for the event, Mr Edward Mmatli, introduced the presenters while SADCA Chair, Mr. Chankar Beekhun gave the welcome remarks

promptly addressed by the organisers and presenters, making for an interactive and engaging webinar experience. Ms. Tshenolo Molamu, SADCA MCC Vice Chair, gave the closing remarks.

SADCA is a Technical Barriers to Trade (TBT) Cooperation Structure established under the TBT Annex to the SADC Protocol on Trade. SADCA currently comprises of a total of 21 Members covering 15 out of the 16 SADC Member States:

 3 Arrangement Members namely: MAURITAS (Mauritius); SANAS (South Africa); and SADCAS (a multi economy accreditation body servicing the accreditation needs of 14 SADCA Member States);

- · 13 Ordinary Members; and
- 5 Stakeholder Members.

SADCA's mission is to manage and expand accreditation recognition arrangements that support SADC industrialisation, facilitate trade and regional integration through credible, reliable and sustainable conformity assessment services that will contribute to the SADC region's sustainable development.



Whether through environmental protection performance, helping manage climate change, developing the circular economy or providing tools to measure performance, accreditation and conformity assessment are constantly reviewed and evolving to ensure that the right tools are available to support the SDGs both now and moving forward. This year's activities to celebrate 2022 WAD were rather limited as nations cautiously adjusted to restrictions brought

The National Accreditation Focal Point Botswana was also involved in organizing the inaugural SADCA Regional 2022 World Accreditation Day Commemoration that was held as a workshop/conference on a virtual platform namely ZOOM (WEBINAR) on the 9th June 2022.

The following WAD 2022 publicity activities were carried out:

- Media Invitations were sent to Private and Government Media Houses on the 15th June 2022.
- A Poster of the Guest Speaker, Date, Time and Venue for WAD was uploaded on MTI Facebook page on the 16th June 2022
- A speech by Minister of Trade and Industry was aired on Radio Botswana I (RB 1) on Thursday 9th June 2022.
- The poster inviting the public to tune in and listen to Minister's Speech was uploaded on Ministry of Trade and Industry (MTI) Facebook page on the 8th June 2022. The poster was also sent to all MTI Staff.
- Press Release was uploaded on MTI Facebook page on the 6th June 2022 and sent to Media Houses.
- The MTI Public Relations Unit (PRU) Coverage-Article was written and photos were taken and uploaded on MTI Facebook page on the 17th June 2022.
- Radio Interviews Tatediso ya Dikgang (a newsreader radio program in vernacular) interview was done and aired on the 16th June 2022.
- Radio Botswana 1 Live Reporting by Alfred Ntshwene.

The workshop and exhibition was held at the Lobatse Civic Hall and was attended by 120 participants from various conformity assessment bodies (inspection bodies/regulators, calibration laboratories, medical laboratories and testing laboratories) from both the public and private sectors, manufacturing, petroleum industry and food processing sectors and policy makers from both the Ministry of Trade and Industry and Lobatse. The workshop was also attended by Lobatse Town Deputy Mayor Hon. Phemelo Masisi, Acting Permanent Secretary Ministry of Trade and Industry Mr. Gideon Mmolawa, Acting Deputy Permanent Secretary Ms. Lesedi Kgotlele, Acting Deputy District Commissioner-Lobatse Mr Ronald Masole, Southern African Development Community Accreditation Service (SADCAS) Technical Manager Ms. Pinkie Malebe and Lobatse Town Deputy Town Clerk (Technical Services) Mr Lentswe NT Lesenyegile among others.

In the Kingdom of Eswatini, World Accreditation Day was celebrated by attending the inaugural SADCA Regional World Accreditation Day Webinar which was celebrated on the 9th June 2022. Forty six (46) participants from Eswatini attended WAD.

On the 10th of June, Eswatini pulled out all the stops to commemorate the 2022 World Accreditation Day nationally to the best of their abilities. The NAFP organized campaigns with the following media houses:

- The Times of Eswatini: A local newspaper which was tasked with running an article on the theme: "Accreditation: Sustainability in Economic Growth and the Environment". The theme touches on how accreditation supports the United Nations Sustainable Development Goals (SDGs 6, 7, 8, 9, 11, 12, 13, 14, and 15).
- The Eswatini Observer: Another local newspaper which was also tasked to run an article on the theme: "Sustainability in Economic Growth and the Environment".
- Eswatini Broadcasting Information Services: The 2nd NAFP (also wearing the hat of Head of the Department) was interviewed on why WAD was celebrated, its relevance, and the impact of accreditation on the economy. The interview was aired by this local TV station.
- Channel S: A local TV station whose audience is mostly people in villages. The 2nd NAFP was interviewed on how Accreditation can sustain the economy and the environment.
- Eswatini TV: The 2nd NAFP was interviewed on the importance of accreditation in sustaining the economic growth and the environment. This interview appeared on the Eswatini news of 10th June 2022.

In Madagascar, the SADCA Regional World Accreditation Day Workshop invitation as well as the SADCAS Press Release was shared to all stakeholders.

In Malawi, a media briefing was set up and a press release on the value of accreditation, its benefits, and this year's theme.

In Mozambique, the link for the SADCA Regional World Accreditation Day virtual Workshop was circulated to the CABs. Additionally, NAFP - Mozambique participated in the seminar organized by the Mozambican Labor Association, in which it contextualized the theme of World Accreditation Day and presented SADCAS as an entity established to respond to the accreditation needs of CABs operating in the SADC region that were without a national accreditation body.

The NAFP recorded a video on the matters related to the celebration of the date, together with the Office of Communication and Image of INNOQ, that was published through professional social networks and other means. He also wrote a press release and distributed it via email to all contacts in the CABs database and other interested parties.


In Seychelles, a half day workshop was organized which features the following presentations which were made by NAFP and Technical Signatories from different accredited laboratories.

ACCREDITATION: SUSTAINABILITY IN ECONOMIC GROWTH AND THE ENVIRONMENT







Accreditation: Sustainability in Economic Growth and the Environment is the theme for 2022 World Accreditation Day which was celebrated worldwide on the 9th of June 2022. The theme highlights how accreditation supports 9 of the 17 United Nations Sustainable Development Goals (SDGs) through the provision of a trusted platform for defining, developing and verifying requirements for products and services while helping to ensure and demonstrate that products and services meet specified requirements. Whether through environmental protection performance, helping manage climate change, developing the circular economy or providing tools to measure performance, accreditation and conformity assessment are constantly reviewing and evolving to ensure that the right tools are available to support the SDGs both now and moving forward.

Accreditation is an attestation of the competence and impartiality of conformity assessment bodies (CABs) to carry out specific conformity assessment tasks. These bodies include but are not limited to calibration laboratories, testing laboratories, inspection bodies, providers of proficiency testing, producers of reference materials, and bodies that certify management systems, products and persons, or undertake verification and validation. Accreditation benefits both a country's domestic economy and its international trade. It helps governments and organizations to meet regulatory and legislative responsibilities and reduce uncertainties in decisions affecting the protection of human health and the environment

The prioritization of sustainability in economic growth and the environment is echoed in the SADC Vision 2050, which was approved during the 40th SADC Summit held in August 2021. Amongst other objectives it strives for an industrialized regional economy that sustainably exploits its natural resources. Industrialization is one of the main drivers of economic growth and sustainable development. Manufactures need to ensure products are of consistent high quality, comply with regulators and standards, and meet specification. Accreditation enables consumers, suppliers, purchasers and regulators to have confidence that products placed on the market are safe and meet the manufacturers claims made about them.

Rapid economic growth may exhaust resources and create environmental problems for future generations, including the depletion of natural resources, and global warming. To support sustainable economic growth, countries worldwide are shifting from a linear to a circular economy. A circular economy disconnects economic activity from the consumption of finite resources by focusing on repair, reuse, remanufacturing and recycling, thus reducing the production of waste and the use of resources.

Accreditation bolsters regulations that implement principles of circular economy by assessing and verifying the claims of conforming companies and organizations.

A sustainable environment for communities in the future needs cleaner energy, reduced pollution, and more effective chemical and waste management solutions to benefit from increased industrialization while safeguarding people and the environment. Accredited testing, certification, and inspection provides assurance that waste management and recycling are being managed effectively.

World Accreditation Day 2022 enables the International Accreditation Forum (www.iaf.nu), the International Laboratory Accreditation Cooperation (www.ilac.org) and their members to highlight how accreditation is delivering sustainability in economic development and the environment. From some of the earliest testing laboratory accreditation activities supporting environmental standards and regulations, to the accreditation of certification bodies for ISO 14001, a sector specific standard focused on environmental performance, and the introduction of standards for validation and verification, IAF and ILAC are seeking to help organizations measure, manage and/or report sustainable economic growth and environmental performance.

The Southern African Development Community Accreditation Service (SADCAS) is a multi-economy accreditation body established in terms of Article 15 B of the Technical Barriers to Trade (TBT) Annex to the SADC Protocol on Trade with the primary purpose of ensuring that conformity assessment service providers operating in those SADC Member States which do not have national accreditation bodies are subject to an oversight by an authoritative body.

SADCAS services the accreditation needs of 14 SADC Member States namely: Angola; Botswana; Comoros; Democratic Republic of Congo (DRC); Eswatini; Lesotho; Madagascar;

Malawi; Mozambique; Namibia; Seychelles; Tanzania; Zambia; and Zimbabwe. SADCAS provides accreditation services to organizations that perform calibration, testing including medical testing, inspection, certification (personnel, product and management systems) and those that provide legal metrology services against international standards.

SADCAS is signatory to the African Accreditation Cooperation (AFRAC) and the International Laboratory Accreditation (ILAC) Mutual Recognition Arrangements (MRA) for the testing and calibration laboratories accreditation schemes in accordance with ISO/IEC 17025 achieved in November 2015, and medical testing in accordance with ISO 15189 and inspection in accordance with ISO/IEC 17020 achieved in October 2017. SADCAS is also signatory to the AFRAC MRA and the International Accreditation Forum's Multi-Lateral Arrangement (IAF MLA) under the Main scope Management Systems Subscopes:

- ISO/IEC 17021-3 QMS in accordance with ISO 9001 achieved on 9 November 2019.
- ISO/IEC 17021-2 EMS in accordance with ISO 14001 achieved on 19 June 2020.
- ISO/IEC TS 17021-10 OHSMS in accordance with ISO 45001 achieved on 19 June 2020.
- ISO/TS 22003 FSMS in accordance with ISO 45001 achieved on 14 October 2021.

Hence the accreditation certificates issued by SADCAS for all the above accreditation schemes are internationally recognized.

SADCAS is now in its 14th year of operation and accreditations continue to grow in terms of field and scope of accreditation, sectorial coverage and also in terms of geographical diversity. As at 31 April 2022, SADCAS has issued 257 accreditation certificates to 207 accredited facilities in 13 SADC Member States and two (2) non-SADC countries (Ghana and Cote d'Ivoire). At the same time, SADCAS had 74 accreditation applications from 12 SADC Member States at the various stages of processing. SADCAS has cumulatively conducted 225 training courses in most SADC Member States as part of its efforts to develop capacity of conformity assessment bodies for accreditation. SADCAS services are focused on the priority sectors for sustainable development in selected value chains as identified in the SADC Industrial Policy.

TANZANIA BUREAU OF STANDARDS -CERTIFICATE SERVICES GRANTED ACCREDITATION

SADCAS is proud to announce the accreditation of the Tanzania Bureau of Standards - Management Systems Certification Services (TBS-MSCS) to ISO/IEC 17021-1:2015. This makes TBS-MSCS, situated at the Junction of Morogoro/Sam Nujoma Roads, Ubungo, Dar Es Salaam, the first certification body to be accredited by SADCAS in Tanzania. Through this accreditation, the TBS-MSCS has been granted accreditation to the following scopes:

- Quality Management Systems to ISO/IEC 17021-1:2015 and ISO/IEC 17021-3:2017 (Certification to ISO 9001:2015), IAF Codes 3 and 12; accreditation number QMS-CERT 004;
- Food Safety Management Systems to ISO/IEC 17021-1:2015 and ISO/TS 22003:2013 (Certification to ISO 22000:2018),
 Category C, Subcategory CI; accreditation number FSMS-CERT 003; and
- Hazard Analysis and Critical Control Point Systems to ISO/IEC 17021-1:2015 (Certification to TZS 1770:2016), Category
 C, Sub-category CII; accreditation number HACCP-CERT 003. This scope is not part of the IAF MLA.

The accreditation certificates were issued for each sub-scope on 28th March 2022 and will expire after 5 years on 27th March 2027.

The accreditation certificate handover ceremony was held on 12th May 2022 at Public Service Social Security Fund (PSSSF) House, 5th Floor, Dodoma, Republic of Tanzania. The ceremony was officiated by the Deputy Minister of Investment, Industry

and Trade - Hon. Exaud Kigahe (MP) and attended by TBS Board Chairman - Prof. Othman C. Othman; TBS Director General - Dr. Athuman Yusufu Ngenya; TBS Director of Quality Management Mr. Lazaro Henry Msasalaga; other TBS Directors; Managers and Certification Staff; representatives of certified entities; other stakeholders and members of the press.

In his opening remarks, Dr. Ngenya, TBS Director General, welcomed all and introduced the guest of honour Deputy Minister of Investment, Industry and Trade, TBS Board Chairman - Mr Victor Rodreck Mundembe, SADCAS Certification Scheme Coordinator —who was to deliver the Accreditation certificates on behalf of the SADCAS CEO Mrs Maureen Mutasa. Dr Ngenya allowed self-introduction to all present.

Mr. Lazaro Henry Msasalaga presented a short History of the *TBS Management Systems Certification Body*.

In his certificate delivery speech, Mr Mundembe started by thanking Dr. Ngenya for the invitation, indicating that SADCAS is very humbled by the honour. Mr Mundembe announced that Tanzania Bureau of Standards – Management Systems Certification Services was the fourth Certification Body among the 14 SADC Member States serviced by SADCAS to be accredited by SADCAS under the sub-scope of Quality Management Systems Certification and the 3rd to be accredited under the sub-scope of Food Safety Management Systems (FSMS) and Hazard Analysis and Critical Control Point (HACCP).

Mr Mundembe further stated that TBS had the largest accredited Metrology scope and was the only organisation that is accredited by SADCAS in the scope of Time and Frequency Metrology, to which there was a huge applause from the audience.

In conclusion Mr Mundembe stated that TBS's vision of "Sustainable standardization for high quality livelihood society" is now underpinned by internationally recognized accreditation provided by SADCAS, this is a guarantee for reliable certification of management systems implemented by TBS clients which serves as assurance of the quality of products from Tanzania.

Keynote address was given by the guest of honour, Deputy Minister of Investment, Industry and Trade - Hon. Exaud Kigahe (MP). Hon Kigahe thanked TBS Management for inviting him to be the guest of honour at the ceremony and expressed pleasure for TBS on achieving accreditation. With those remarks, the Honourable Deputy Minister was ready to receive the accreditation certificate from the SADCAS representative. Mr Mundembe proceeded to hand over the 3 accreditation certificates and the accompanying Schedules of Accreditation.

The session was closed off with ululations, photo shoots and a filling Tanzanian luncheon.

SADCAS HANDS OVER ZAMBIA COMPULSORY STANDARDS AGENCY (ZCSA) ACCREDITATION CERTIFICATE

The Zambia Compulsory Standards Agency (ZCSA) is an independent government entity under the Ministry of Commerce, Trade and Industry enacted by the Compulsory Standards Act No. 3 of 2017 with a mandate to maintain and ensure compliance with compulsory standards in Zambia. ZCSA is responsible for the enforcement of implementation of compulsory standards for locally produced and imported products. ZCSA located at Sefalana House, Stand Number 5032, Great North Road, Lusaka, Zambia got accredited by SADCAS on 14 April 2022 as a Type A, a third-party independent inspection authority.

Through this accreditation Zambia Compulsory Standards Agency has been granted the unique accreditation number INSP- 1 003 indicating that Zambia Compulsory Standards Agency is now an internationally recognized inspection body accredited to international standard ISO/IEC 17020 for inspection of Food products (Bottled Water and Maize Meal) imported and manufactured in Zambia. The certificate of accreditation which was issued on 14 April 2022 is valid for 5 years until 13 April 2027.

SADCAS attended a Certificate Hand-Over ceremony that was held on 03 June 2022 at Radisson Blu Hotel, Lusaka Zambia. The Ceremony was officiated by the acting Permanent Secretary, Ministry of Commerce, Trade and Industry Ms Nalituba Mwale on behalf of the Minister of Commerce, Trade and Industry Honourable Chipoka Mulenga. The occasion was graced by Senior Government officials and Heads of various stakeholder institutions and the acting Executive Director of ZCSA Mr Gerald Chizinga. Mrs Pinkie Malebe was invited on behalf of the SADCAS CEO to perform the official handing over of the accreditation certificate.

In his opening remarks, the acting Executive Director Mr Chizinga recognized all dignitaries present and the SADCAS representative Mrs Pinkie Malebe. He jubilantly stated that the day marked the culmination of the hard work put in by all team members as they sought accreditation and was happy to host the ceremony to show how elated they were to have been accredited. Along with his management team, Mr Chizinga committed to ensuring that ZCSA continues to comply with the requirements of the international standard ISO/IEC 17020:2012, regulatory requirements and the accreditation body requirements.



On presenting the accreditation certificate to the acting Permanent Secretary, Mrs Malebe gave a brief background on SADCAS as a multi-economy accreditation body mandated to offer accreditation to 14 SADC members states, including Zambia, that do not have a national accreditation body. She stated that SADCAS had by then accredited 207 facilities in 13 countries within the SADC region, 17 of which are from Zambia. Mrs Malebe reported that ZCSA is the 1st Inspection body in Zambia to be accredited by SADCAS, the 9th in the 14 SADC Member States the serviced by SADCAS and the 2nd inspection body to be accredited for import inspection.

In her acceptance speech, the acting Permanent Secretary Ms Mwale thanked SADCAS and congratulated team ZCSA for a job well done and the grand milestone that will serve as a basis of confidence in the services offered by the agency, for the benefit of the country Zambia. The ceremony was closed by the president of the Millers Association of Zambia.



SADCAS is proud to announce the accreditation of the Spectrum Laboratories & Consultancy Namibia CC in the scope of Mass Metrology to ISO/IEC 17025:2017. This makes Spectrum Laboratories & Consultancy Namibia CC, situated at Unit 9, Northern Industrial, Windhoek, Namibia, the first privately operated calibration laboratory to be accredited by SADCAS in Namibia. Within the geographical area of the SADC members states serviced by SADCAS, Spectrum Laboratories & Consultancy Namibia CC is the third private calibration laboratory to be accredited. Through this accreditation, Spectrum Laboratories & Consultancy Namibia CC has been granted the unique accreditation number CAL-8 012 (Mass Metrology), indicating that Spectrum Laboratories & Consultancy Namibia CC is now a SADCAS accredited Calibration laboratory. The certificate which was issued on 1 June 2022 expires on 31 May 2027.

Upon receiving the notification that the SADCAS Accreditation Approvals Committee (AAC) had reached the decision to grant accreditation, the Director of Spectrum Laboratories & Consultancy Namibia CC, Mr Leevi Sakeus indicated that this news was met with hysterical excitement at the laboratory. He stated that "the date on which the accreditation was granted marks exactly one year since Spectrum Laboratories & Consultancy Namibia CC was operationalised". Operationalising and getting the laboratory accredited within one year is unprecedented for all conformity assessment bodies accredited by SADCAS, making it a truly remarkable achievement by Spectrum Laboratories & Consultancy Namibia CC.

The SADCAS Calibration Laboratories Accreditation Scheme (CLAS) was established in October 2009 and is operated in accordance with ISO/IEC 17011 the standard that specifies requirements for accreditation bodies accrediting conformity assessment bodies. Accreditation certificates issued by SADCAS for calibration laboratories are internationally recognised following the achievement of signatory status in the International Laboratory Accreditation Cooperation Mutual Recognition Arrangement (ILAC MRA) for calibration in accordance with ISO/IEC 17025 in November 2015. ISO/IEC

17025 specifies accreditation requirements for calibration laboratories. It is the international standard against which calibration laboratories are accredited.

JC WG on Sustainability

- Purpose of WG is to:
 - Ensure IAF retains a competent and up-todate focal point for strategic consultation and dialogue on sustainability issues with key partners, starting, but not only with ILAC and ISO.

- Identify strategic priorities for IAF Executive and IAF members to consider within its decision process.
- Explore the need to establish liaison with external partners and with interested parties that are new to IAF.
- Share experiences and commission research on the current and future market and explore the solutions including discussing standards and schemes that exist and are emerging in this area.

JEC Task Force on ISO/IEC 17029

- It was proposed that a small Joint Task Force be established to develop a communique which shall include:
 - A description of the overlap that may occur between the three standards (ISO/IEC 17029, ISO/IEC 17065 and ISO/IEC 17020)
 - The cooperation mechanisms between the two organisations for ensuring that the most appropriate inputs into scheme acceptance processes.

IAF MD 25:2022 Criteria for Evaluation of Conformity Assessment Schemes

Presented by Emmanouil (Manolis) Geneiatakis, IAF UAC Chair.

Issue 1 was published on 07 January 2022 with an application date of 07 January 2024.

This document contains minimum requirements for conformity assessment schemes (CAS) to be applied by IAF member ABs when evaluating national, regional or international CAS to ensure they meet requirements specified in ISO/IEC 17011, Clause 4.6.3.

Does not apply to the following CAS:

- Those that are included or invoked by legislation/ regulation, and/or;
- Developed by national, regional or international standardisation bodies

Clause 3: Requirements for the Scheme Owner

Clause 4: Requirements for the CAS Document(s)

Clause 5: Evaluation Process

• Amendment of IAF MD16 to reflect ISO 17011:2017.

The 30-day comment period for this document is complete. However, since the revised ISO 22003-1 will be published on 7 June 2022, it was discussed and in advance agreed with the TC chair that the WG Food will re-establish a group of volunteers to engage in bringing the current (MD16) draft, the comments received in 2021 plus the possibly new content of ISO 22003 in line.

Next step: convenor WG Food (Hartmann) to prepare a further working draft and discuss the same with volunteering members of the WG.

Status: In-Progress.

IAF Food Task Force feedback on Race to the Top (RTTT) Feature 3

Meetings were completed for the TF GFSI RTTT Feature 3 on December 16, 2021, January 11, and January 21, to discuss final comments and finalization of KPIs. It was confirmed the TF supporting Feature 3 would be closed based on this task.

Status: Completed.

The meeting for the TF GFSI RTTT Feature 3 for how performance measures could be consistently adopted by CBs, ABs and CPOs was held on March 2, 2022. Follow-up meeting on March 11, 2022 with co-convenors and Kevin Belson, IAF TC Chair proposed a New Work Item Proposal (NWIP), to request either a new IAF ID document, or consider

requirements in the revision of IAF MD 15 – Collection of Data to Provide Indicators of Management System Certification Bodies' Performance. For the project proposal, a new workplan with deliverables and timelines will be defined with a request to form a new task force.

Status: In-Progress.

GFSI feedback on progress from Race to the Top (RTTT)

The GFSI RTTT project progress was presented by Marie-Claude Quentin. RTTT feature 4 is related to a database on GFSI-certificates (no link to IAF CertSearch anymore) - in development and going live in summer 2022.

Status: In-Progress.

ISO 22000 updates

ISO 22000 expected Outcomes document.

This document was requested for a final review with a small group which included representatives from ISO TC/34, CASCO and IAF. The review was signed off as successful on February 7, 2022. The brochure is now with the ISO communications team who are preparing this for publication.

Status: In-Progress.

ISO 22000 Auditing Practices Group (APG).

Co-convener Colin Christmas and Joana dos Guimarães presented to ISO TC 34 / SC 17 at their plenary meeting, November 25 to harmonise audit approaches for ISO 22000 similar to both ISO 9001 APG, ISO 14001 APG and the soon to be established ISO 45001 APG. Draft Resolution 217 was approved on February 14, 2022. 4–5 papers are planned to be published by end of 2022.

IAF Food WG participation in the following Electronic Work Groups (EWGS) and discussion paper for Codex Committee on Food Import and Export Inspection and Certification Systems (CCFICS)

During the WG Food Meeting, members raised questions in relation to the final target in relation to the (now) two-fold standard and its purpose. The need for **an official transition document** was discussed (further project proposal according to IAF rules necessary).

SADCAS UNDERTAKES TARGETED MARKETING VISIT IN COMOROS

Comoros became a new member of SADC in 2018 and was recently added to the member states that are serviced by SADCAS. In its bid to understand the Comoros market and create awareness on accreditation and SADCAS services, SADCAS conducted a 3-day targeted marketed visit to Moroni, Comoros Island from 23 – 25 May 2022. SADCAS has been undertaking targeted marketing visits to all its missions and the visit to Comoros had been planned for March 2020 but could not materialize due to the COVID-19 pandemic.

The purpose of the visit was to:

- Introduce SADCAS to Comoros, specifically the policy makers and conformity assessment bodies;
- To pre-sensitize the government of Comoros on contributions towards SADCAS sustainability for the strategic period 2022 – 2027;
- To create awareness on the importance of accreditation as well as to appeal to the Comoros government to support the office of the National Accreditation Focal Point (NAFP).

The SADCAS delegation consisted of Mrs Maureen Mutasa - the SADCAS CEO, Mrs Pinkie Malebe - SADCAS Technical Manager and Ms Varsha Gungoa - the Scheme Coordinator for Testing Laboratories who mainly served as a French translator for SADCAS as Comoros is a French-speaking country.

On the first day, the delegation met with Mr. Mohamed Boinali, NAFP-Comoros, and gave him an introduction of SADCAS as well as an update on developments in SADCAS. The delegates then outlined the roles and responsibilities of the NAFP to the NAFP Supervisor – who was also in attendance.

SADCAS CEO, Mrs Maureen Mutasa, gave the presentation about SADCAS, its legal identity, its mandate, affiliation, achievements and organizational structure. The presentation focused on what accreditation is and the need for and importance of accreditation. The NAFP and the supervisor reported that the Comoros would need the assistance of SADCAS with regards to setting up the Quality Infrastructure and creating awareness of accreditation in Comoros as well as training CABs on accreditation related standards.

The SADCAS delegation later convened with the NAFP unit to the office Mr Ahmed Ali Bazi, the Minister of Economy, Investments and Economic Integration and Acting Permanent Secretary, Mr Mouingi Saandi, to discuss governance issues and pre-sensitization on the contribution by member states towards SADCAS sustainability.

During this meeting, the CEO expounded on the SADCAS funding model and the expectation for member states to make their contributions which are based on the country's market size. The CEO took the opportunity to appeal to the office of the Minister to support the office of the NAFP by providing a budget to carry out national action plans as well resourcing with unit with an office space and equipment.

The main challenges of the mission were the language barrier and a lack of developed quality infrastructure within the Comoros. On the language barrier, the CEO reported that SADCAS offers services in the 3 official languages namely English, French and Portuguese and that SADCAS is working to include recruitment of French speaking personnel to assist with French applications as well to translate of documents to French. The CEO pledged to assist by providing guidance to the NAFP office to seek assistance and submit proposals for funding from the SADC secretariat.

Regarding the Member state funding towards SADCAS' sustainability, the CEO reported that the contribution is based on the number of CABs in the country as per the information provided by the NAFP- Comoros. She sited that Comoros' contribution is US\$ 12,980 to be paid by 31 March 2025 in 3 instalments as follows:

- US\$ 4,327 by 31 March 2023
- US\$ 4,327 by 31 March 2024
- US\$ 4,327 by 31 March 2025

MARKETING AND PROMOTION

She reported that funding for SADCAS is on the agenda for the TNF meeting being held from 23 to 25 May 2022 and subsequent meetings of the SADC Senior Officials and the SADC Committee of Ministers of Trade. The Minister ensured the delegate that Comoros will pay its dues as required.

On the second day, SADCAS conducted an awareness workshop for CABs based in Moroni, Comoros. The aim of the workshop was to create awareness of accreditation, to determine the level of implementation of accreditable standards within Comoros and to give an overview of the SADCAS Accreditation Process and Training Services.



The half-day workshop was attended by 25 participants from various private and public institutions that included Testing, Medical, Research and University Laboratory and Exporter agency. Mr Ali Ahmada Chaher, the Director of Industry, did the opening remarks while the SADCAS CEO, Mrs Maureen Mutasa, gave an overview of SADCAS and Developments in SADCAS. Mrs Pinkie Malebe gave a presentation on Accreditation Services and Training Services

On the 3rd day, SADCAS visited 3 testing laboratories to establish the level of awareness on accreditation, applicable standards and their implementation. The general observation was the need for training on the applicable standards, training on implementation of the standards and unavailability of Proficiency Testing programmes and calibration services.

The 3 laboratories visited were:

I. INRAPE (National Research Institute for Agriculture, Fishing and Environment) where the SADCAS team met with the Quality Manager of the laboratory Mr Moukhtar Maecha. The laboratory conducts chemical testing of water and food products and conducts quality testing for Vanilla which is a main export product in the country. Inrape picture below;



SADCAS QUALITY MANAGER PRESENTS A PAPER AT THE BOTSWANA INTERNATIONAL HEALTH EXPO 2022



The Annual Botswana International Health Expo 2022 was held from 16 – 17 June 2022 in Gaborone. The aim of the expo was to unlock the value chain in the health care services and improve the standard of care. The event attracted business leaders, consumers, investors and stakeholders within the healthcare delivery industry. On the first day of the expo, the Southern African Development Community Accreditation Services (SADCAS) Quality Manager, Mr. Xavier Mugari, had the honor of presenting a paper.

The theme of the expo was Delivering Innovative & Quality Health Care Services & Products; a Key Step to a Healthy Nation. Well aligned with the event's theme, Mr. Mugari's paper — entitled "Accreditation: Ensuring Delivery of Quality Healthcare and Innovation" outlined the imperative that necessitates the appropriate alignment of accreditation, quality improvement and regulation in health care services to achieve the continuous, incremental and sustainable impact on quality of patient care.

The instrumental presentation began with a definition of accreditation and its connection to innovation, before delving into the relevance of and the need for accreditation in healthcare organization. In his paper, Mr. Mugari argued that through accreditation, healthcare organisations can demonstrate their ability to deliver quality healthcare, manage innovation activities to achieve intended patient outcomes and enhance patient satisfaction. He also presented a conceptual framework for innovation in healthcare.

For over a decade, Mr. Xavier Mugari has been a significant contributor to the field of Quality Management in the region. As the Quality Manager with the SADCAS, he is chiefly responsible for managing the SADCAS Quality Management System (QMS) to ensure that it complies with the requirements of ISO/IEC 17011, African Accreditation Cooperation (AFRAC), SADC Cooperation in Accreditation (SADCA), International Laboratory Accreditation Cooperation (ILAC) and International Accreditation Forum (IAF) requirements.

SADCAS Quality Manager Xavier Mugari gave the presentation, entitled **Accreditation:** Ensuring Delivery of Quality Health Care & Innovation, which spoke to the necessity of accreditation in the health sector and called regulators and decision makers to action regarding policies around it. In attendance of this presentation were various investors and media press. Viewing that this was the second presentation of the expo, this presentation offered SADCAS optimal visibility.

Following the presentations, time was given for investors to visit the stalls. SADCAS Technical Manager Pinkie Malebe, MLAS Scheme Coordinator Eva Muronda, Finance and Administration Assistant Intern Mmamotse Gaotilwe and Marketing & Communications Intern Nicole Sekgoma received stall visitors.

The expo served as a platform for a number of other presentations and breakaway sessions, including **Cow's**Milk Protein Allergy & Identification and Dietary

Treatment by Dr Chris Masikara of the Allergy Centre and

Nutritional Support during Disease Related Malnutrition

by Mr Moseja Dibotelo of Mint Condition Health Consultancy to name a few.

Visitors to the SADCAS stall included professionals in the sectors of calibration, medical imaging, chemical production, pharmaceutical graduates and general enquirers.

The success of this event was possible because of the collaborative effort of the task force and SADCAS staff.

NAFP - LESOTHO AT THE FRONTLINE OF PROMOTING ACCREDITATION IN LESOTHO

Accreditation continues to be the epitome of acceptance for test data in trade and other disciplines. In Lesotho, the health sector seems to be realizing the significance of accreditation for diagnostics.

It is also worth noting that the COVID-19 pandemic diminished the enthusiasm and envisaged progress by potential clients on establishing requisite accreditation systems.

As the pandemic subsided, face to face marketing visits by NAFP Lesotho were recommenced and it is beginning to bear fruit.

NAFP Lesotho, hand in hand with the Lesotho Federation of Laboratories has been active in promoting accreditation. Presently, there are two laboratories in the medical sector which are due for SADCAS assessment.

Additionally, NAFP Lesotho has planned a virtual training on ISO 15189 that is due in August 2022. It is hoped that following through this training more medical laboratories are going to earnestly work on their systems and work towards gaining accreditation.

Interest in accreditation is not only from the health sector, but also the Lesotho Electricity and Water Authority water testing laboratory. Laboratories Federation of Lesotho (LFL) will soon conduct an internal audit. There is also a renewed drive from our Forensic laboratory to further improve her system for assessment.

Furthermore, the National University laboratory and the Agricultural Research laboratory - which tests Genetically Modified Organisms, have completed their quality system documentation and will submit their applications as soon as funding is available.

It is worth mentioning that whilst we realise that training encourages accreditation, we are facing challenges of diminishing budget and therefore are not able to give the requisite support as we wish.

This year we were able to rope-in the inspection bodies through the SADC/SADCAS support. We are indeed grateful, and we are following up on them.

Despite these challenges, the Department of Standards Metrology laboratory has made commendable strides to establishing their quality system. NAFP Lesotho continues to put her foot on the pedal to catch up with rest of the region.

UNDER THE EYE OF THE ASSESSOR - TESTING LABORATORIES ACCREDITATION SCHEME

Mr Paki Israel Dikobe is a South Africa based Scientist. He is currently affiliated with the following organisations: South African Council for Natural Scientific Professions (SACNASP); Water Institute of Southern Africa (WISA) and South African Chemical Institute (SACI). He has worked in the water industry and forensic laboratories for 17 years - 16 of which were spent working in an accredited laboratory. Due to his vast experience, he was recruited, trained and registered with SANAS as a Technical Assessor and later as a Team Leader.

He was recently registered by SADCAS as a Technical Assessor. He is passionate about conducting assessments and has attended various courses/training i.e ISO/IEC 17025; Internal Auditing, Technical Assessor, Documenting the system etc. He is currently registered with UNISA for his

PhD: Environmental Science studies and possesses M-Tech: Water Care (Cum Laude), B-Tech: Laboratory Management (Cum Laude) and B-Tech: Chemistry. He is a married man and a father of two kids.



UNDER THE EYE OF THE ASSESSOR - MEDICAL LABORATORIES ACCREDITATION SCHEME

Lisema Phafane hails from the mountain Kingdom of Lesotho. He completed his Diploma in Biomedical Sciences in 2003 the National Health Training College (Lesotho) and then furthered his studies at Central University of Technology (RSA) where he obtained Bachelor of Technology in Biomedical Technology. He also holds an Advanced Health Management Certificate in Health Management. He is currently pursuing his Master's degree in Health Sciences with Central University of Technology (RSA).

He has work experience spanning over 2 decades from various Clinical Laboratories in Lesotho where his main focus was in clinical Pathology and his area of expertise is in Hematology.

Lisema completed ISO 15189 Lead and Technical Assessor training in 2016 and was registered as a technical assessor in 2020. Thereafter, he got approval to participate in an assessment under observation in October 2021.

In the early days of 2022, he took the opportunity to conduct an online assessment by himself. He found the experience exciting despite internet connectivity challenges. In contrast, Mr Phafane found that onsite assessment where different from virtual assessments in that they brought a lot of pressure to complete the assessment on time since the completion in time was dependent on the instant availability of evidence when required. Above all the challenges, it was thrilling to construct a meaningful observation (NC) onsite, while in the middle of the assessment that needed to be completed within a stated time frame.



UNDER THE EYE OF AN ASSESSOR - CERTIFICATION BODIES ACCREDITATION SCHEME

Mr. Melchiol Ambunda is a Namibian citizen with vast experience in standardization and conformity assessment. He has been registered as a Technical Assessor with SADCAS since April 2018 under the Certification Bodies Accreditation Scheme for the sub-scopes QMS and FSMS and his background is Food Science and Technology. He has conducted both on-site and remote assessments of certification bodies.

He noted that the outbreak of COVID-19 which halted ononsite assessments, made remote assessment the most viable option available. Even though remote assessments have more challenges than on-site assessments, availability of reliable information and communication technologies made it possible for SADCAS to conduct effective remote assessments. Additionally, the use of IAF MD 4 document in the planning and execution of an assessment became valuable to the assessment teams.

The disruption of the global supply chain - brought on by the COVID-19 lock-down, drove many economies to find alternative suppliers thus increasing the requirement for local/regional suppliers to demonstrate the safety, security and reliability of their products and services.

The most globally accepted way of demonstrating conformity is through the use of accredited certification service; as goes the IAF/ILAC motto "Accredited once, accepted everywhere".

Combined, these new dynamics in the market has made our responsibilities as assessors (to collect sufficient objective evidence) more complex. Therefore, Ambunda recommends that continual training of assessors is essential to ensure that they remain updated with new and emerging industry assessment best practices.



UNDER THE EYE OF AN ASSESSOR - MOOKHO MORIENYANE

Mookho Morienyane has been an Assessment Specialist for the SANAS Certification Program since 2017 for the standards ISO/IEC 17021-1, ISO/IEC 17065, ISO/IEC 17024 and ISO/IEC 17029 and is also a technical assessor in the food and chemical sectors

From 2018, she began conducting assessments as a registered SADCAS assessor. She is passionate about the assessment process and being able to play an important role in assisting conformity assessment bodies improve their management systems and thus achieve and maintain their accreditation status. SADCAS is committed to ensuring that assessors achieve this through assessor training sessions and workshops as well as frequent interactions with every team member involved with delivering accreditation.

For Mookho, being an assessor involves a lot of travel, internalizing and applying high volumes of technical information and working alongside people with different backgrounds. Over and above having to understand the requirements of the Accreditation Standards and the facilities' management systems, assessors must understand the requirements of additional normative and reference documents such as competency standards for several management system schemes, IAF mandatory requirements or any specific scheme requirements in the case of product certification.

Mookho found that transitioning from onsite assessments to remote assessments during the COVID pandemic has added a new dimension to assessment process. Even though the format of the remote assessment is not dissimilar to a face-to-face assessment, it has also been a challenging mode of work in terms of internet connections and sharing of information especially during activities such as witnessing which require file sharing and risk being time consuming.

"I have been looking forward to resuming onsite assessments and engaging with the facilities face to face, however, from the remote assessments many positive lessons have been learnt."

Through interaction with the participants in the training, she gained insight on how remote training courses are provided. SADCAS HANDS OVER SCOTTISH LIVINGSTONE HOSPITAL LABORATORY ACCREDITATION CERTIFICATE

On 16 May 2022, the then SADCAS Chief Executive Officer Mrs Maureen Mutasa and the SADCAS Technical Manager Mrs Pinkie Malebe joined multitudes of guests that congregated at the Scottish Livingstone Hospital Laboratory in the village of Molepolole in Botswana to witness the accreditation certificate handing over ceremony.

The Scottish Livingstone Hospital Laboratory, situated at Goo Ntloedibe Ward in Molepolole, is the 11th medical laboratory to be accredited by SADCAS in Botswana and the 91st in the 14 SADC Member States serviced by SADCAS. Scottish Livingstone Hospital Laboratory was granted accreditation to the international standard ISO 15189:2012 on 16 March 2002 for seven (7) scopes namely Clinical Chemistry, Haematology, Immunology, Blood Banking, Molecular Biology, Mycobacteriology and Serology and has been granted the unique accreditation number MED 096 indicating that Scottish Livingstone Hospital Laboratory is now an internationally recognized medical laboratory.

When handing over the certificate, Mrs Maureen Mutasa congratulated the Scottish Hospital Laboratory and Laboratory staff for their noble achievement. She advised the gathering that the accreditation certificate is valid up to 15 March 2027, a 5-year cycle within which SADCAS will be conducting periodic assessments to verify continued compliance with the requirements of ISO/IEC 15189 and accreditation requirements.

In accepting the certificate, the Minister of Health Dr Edwin G Dikoloti congratulated the Scottish Livingstone Laboratory and the hospital management for the grand achievement. He pledged his continued support and encouraged staff to continue to work hard to ensure maintenance of the hard-earned accreditation.

SADCAS HOLDS ISO 15189:2012 REQUIREMENTS AND INTERNAL AUDIT TRAINING COURSE

From 27 June to 01 July 2022, SADCAS held a virtual training course on ISO 15189:2012 Requirements & Internal Auditing. This course was conducted by Dr. Farojdeo Hemraj - a long servicing registered SADCAS trainer and attended by nineteen (19) participants from 5 organizations; Biomedical Research and Training Institute — BRTI (7), University of Zimbabwe (1), CIMAS Health Group (6), Diagnofirm Medical Laboratories (3), and Mwaiwathu Private Hospital (2).

The event began with welcome remarks by Mr Mogae Molaoa, SADCAS Training Administrator, who highlighted the importance of the training and gave a brief introduction of the SADCAS - whose headquarters are located in Botswana in addition to National Accreditation Focal Points which are based in 14 SADC countries.


Dr Hemraj started the course by giving an overview of what laboratory accreditation is, the benefits of accreditation and an explanation of the difference between certification and accreditation. He elaborated on important terms related to accreditation after giving the scope of the new ISO 15189: 2012.

A practical session was organized in which each participant was given to opportunity to carry out an internal auditing based on their selected clauses from the checklist and to document the nonconformities identified. After each participant presentation, the class commented and discussed on the exercise.

Other issues that were covered by the training course included intra Quality Control, External quality assessment, measurement uncertainty. The topic of method validation and verification was further discussed and the concept of measurement uncertainty was introduced. The importance of internal auditing was highlighted.

During the closing session held on the last day of the course after the examination, the trainer thanked the participants for their keen interest and focus throughout the course which made the training course successful particularly through the regular interaction and fruitful discussions on pertinent topics. One of the participants, Ms Elaine, on behalf of the class gave a vote of thanks to SADCAS and the facilitator for providing this important training workshop.

BOTSWANA POLICE - FORENSIC DEPARTMENT TRAINED ON ISO 15189



The ISO I5189:2012 Requirements and Internal Audit Course was conducted from 04 – 08 July 2022 at Fairgrounds Holdings – Ditshupo Hall in Gaborone, Botswana. The training was organized by SADCAS and was attended by 10 participants from Botswana Police Service – Forensic Laboratory. The participants comprised of Anatomical Pathologists, Medical Laboratory Scientists and Laboratory Technicians.

The objective of the 5-day training was to train staff on the requirements, implementation and auditing in accordance with ISO 15189:2012.

The training started with registration of all the participants followed by the welcome remarks given by Mr Mogae Molaoa, SADCAS training Administrator, who highlighted the

importance of the training. This was followed by remarks given by Mr Edward Mmatli – NAFP for Botswana who gave a brief introduction of SADCAS. He then proceeded to introduce the SADCAS Trainer Mr Xavier Mugari, who is also a Technical Assessor, Team Leader and the SADCAS Quality Manager.

The training course was interspaced with exercises. The wide collection of experiences by the participants. A practical session was organized in which each participant was given an opportunity to carry out an internal audit based on selected clauses from the checklist and to document the nonconformities identified. In addition to being continuously evaluated during the training course, participants undertook an examination at the end of the training.

PERFORMANCE LABORATORIES CHANGES OVER TO SADCAS

Performance Laboratories, located in Ruwa, Zimbabwe, was established in 2011. Shortly after its establishment, the laboratory earned accreditation from SANAS for the Gold Fire Assay. Since 2011, the laboratory has expanded its testing base to include multi-acid digestion techniques to service a wider and growing need in the country.

As times moved on and ownership of the laboratory changed hands, its association with a South African based laboratory came to an end, thus accreditation by SANAS was no longer an option for Performance Laboratories. With the healthy mining industry in Zimbabwe still demanding world class service and accreditation by an international body, Performance Laboratories applied to SADCAS for accreditation. The application included the Fire Assay for Gold and PGM's, and multi-acid digestion of 7 base metals namely Cobalt, Copper, Lithium, Manganese, Nickle, Lead

and 7inc.

COVID-19 presented some unusual challenges with limited travel. This posed a seemingly insurmountable challenge to the accreditation process. It was refreshing to see that SADCAS had taken to the times by using technologies available; allowing the team to work through the assessment process remotely, sending through the required documentation via email, performing verifications through online videos and streaming live processes and meetings. This initiative by SADCAS made the process seamless and it worked very effectively.

Performance Laboratories is now officially accredited by SADCAS and we hope this is the beginning of a long and mutually beneficial relationship between the two organizations.

When handing over the certificate of accreditation, the SACAS Technical Manager Mrs Pinkie Malebe congratulated the Municipal Council of Manzini and announced that Municipal Council of Manzini is the 11th Conformity Assessment Body in Eswatini to be accredited by SADCAS, the 208th in the 14 SADC Member States the serviced by SADCAS. The Municipal Council of Manzini situated at Ngwane/Nkoseluhlaza Street, Manzini, Eswatini has been accredited for Microbiological Testing of Drinking and Raw Water in accordance with the International standard ISO/IEC 17025:2017.



Through this accreditation Municipal Council of Manzini has been granted the unique accreditation number TEST-1 0024 indicating that Municipal Council of Manzini is now an internationally recognized laboratory for testing of Total Coliforms and E.coli in both drinking and raw water. The certificate of accreditation which was issued on 21 May 2022 is valid for 5 years until 20 May 2027.



In his acceptance speech and on behalf of the honourable Minister of Housing & Urban Development, the Principal Secretary Ambassador Clifford Mamba, commended the Municipality for working hard towards accreditation of its laboratory. He said that the accreditation will boost investor confidence on the services offered by the Kingdom.

Minister of Commerce, Industry & Trade, represented by the Registrar of Companies Mr Msebe Malinga, said the accreditation would attract new markets - locally and internationally.
